## **Complete Part 1**

- 1. Please enter the date of the request.
- 2. For the year of distribution the deadline for request receipt is April 15.
- 3. Send all requests to the Chairman of the Endowment Committee. The chairman's address will be updated on the form as the Chairman changes.
- 4. Provide the name of the person and/or organization requesting the funds. Also provide the LWML Zone in which the person/organization is located.
- 5. Provide all contact information of the requestor(s).
- 6. Assign a title to the request. Please see sample completed form for ideas.
- 7. Provide the details of the request including how it fulfills one of the goals (see below for goals) and the associated costs. Please note the funds do not have to be spent at the time of the request but must be spent before the costs are reimbursed unless there are approved extenuating circumstances. The extenuating circumstances must be provided in the initial request and approved by the committee before the funds will be provided ahead of spending them.
- 8. The requestor will be notified by the Endowment Fund Committee Chairman whether the request has been approved. If approved, an accounting will be expected as soon as possible to receive the funding (unless it has been approved for pre-funding by the committee). If approved for pre-funding, the accounting will be expected as soon as the funds are spent.

9. The expectation is that the recipient(s) will be blessed by the funds and will provide of summary of those blessings. The summary will most likely be published in the LWML MSD "League Letter", on our website, and on our Facebook page, as well as other avenues.

## **Fund Goals**

Purpose of the request must be limited to the two goals listed below from the LWML Mid-South District Endowment Fund Guidelines unless there have been funds donated for a restricted purpose and the restricted purpose of the donation has been approved by the LWML Mid-South District Board of Directors.

- Scholarship Assistance Will provide for but not be limited to scholarships/subsidies in full or in part for LWML MSD members. This monetary assistance will be eligible for use in attending LWML national events and conventions, LWML Mid-South District events, conventions, and retreats or for other events that may be of benefit to service in the LWML.
- Leader Development Will focus on, but not be limited to, any expenditure or purpose related to leader development of current LWML MSD leaders offered by national or district LWML. It may also be used by current LWML Mid-South District leaders or members to attend events, seminars, meetings, on-line courses, and college courses that will enhance their skills and be of benefit to ministry in the LWML.
